Planning and Zoning: Report to follow in separate agenda item.

Historic Preservation: The chair of the committee reported that the Historic Perservation Potluck was well attended. A partial demolition of a carport on Travis Heights Blvd in order to make room for additional dwelling is not opposed by the committee.

Finance Committee: The committee discussed sharing the SRCC parks Foundation account with a neighbor for the improvement at Harper's Branch, but it may not be necessary as he may get his own.

Mobility: There was discussion about the Living Streets Program, which encompasses three types of resident-led street activations:

- 1. Neighborhood Block Parties—One time closing of a single block.
- 2. Healthy Streets-Provides space for people to walk, bike, and exercise. Public right of way is discouraging through traffic.
- 3. Play Streets—Allow Residents to partially close a single block to motor vehicle traffic for a few hours per day, several days a week.
- 4. A member commented that Alameda is used as a cut-through and this would be a way to curb that.

Public Safety: Package theft is a problem, as well as people walking in unlocked doors. Keep your doors locked! A member stated that there were two separate thefts of motorcycles of neighbors, so secure your motorcycles.

Parks and Environment: There is a monthly volunteer opportunity at Blunn Creek Prserve. The next event is scheduled for Saturday, December 7th from 8:30-12:00. Justin Haynes met with Zo Quadri hoping to obtain support for restoring the area east of Kenwood (Harpers Branch Creek Greenbelt).

Schools: There is an open house at Lively Middle School on the evening of Friday, December 6th 5:30-7:00. It is called "The Evening of Wonder" and is an opportunity for students and families who might want to attend Lively in the future.
